

### FACTUAL BASIS/PROFFER OF TESTIMONY

On or about May 23, 2017 Malik Davis along with Destiny Barrett in a vehicle borrowed from Brandon Giangrosso picked up Jacquelyn "Daisy" Landry from her home located at 229 Crooked Creek Rd in Lafayette Parish. After picking up Jacquelyn Davis and Barrett went a residence located at 3750 Landry Rd in Lafayette Parish. At the Landry road Residence, Davis and Jacquelyn Landry snorted Methamphetamine. Jacquelyn Landry remained with Davis in the vehicle while Barrett entered the residence. At some point Brandon Giangrosso an occupant of the house asked Davis to bring Jacquelyn Landry to another location because she was not allowed at the Landry Drive home. Davis then left with Jacquelyn Landry in Brandon Giangrosso's vehicle while Destiny Barrett remained at the Landry Drive home. Davis and Landry traveled to Davis's home located at 104 Laguna Drive in Lafayette Parish. Davis lived at that residence with Charles "Wes" Franciol, Matthew Perez, and Devan Dufour. Also present at the residence was a 3-4yo child. When Davis arrived with Jacquelyn Landry; Matthew Perez and Devan Dufour were present at the Laguna residence in the living room. Jacquelyn Landry and Davis went to Davis's room located upstairs in the residence. Davis and Jacquelyn Landry again snorted methamphetamine in Davis's room. At some point Davis took a shower and Landry remained in the bathroom with Davis. When Davis emerged from the shower Jacquelyn Landry asked if Davis would smoke a cigarette outside with her. Davis and Jacquelyn Landry went outside at the Laguna residence at which time Jacquelyn Landry started to act out of the ordinary. Landry was talking quietly and then began to act erratically. Davis was in possession of Heroin and it offered Jacquelyn Landry. Landry indicated that she was in possession of a needle to administer the Heroin. Devan Dufour agreed to administer the Heroin to calm Jacquelyn Landry down. Devan Dufour along with Jacquelyn Landry went upstairs to Davis's room. A short time later Dufour came back downstairs and returned the remaining Heroin. Approximately 45 minutes later Davis went upstairs to check on Jacquelyn Landry and he found her cold to the touch and without a pulse. At this time Devan Dufour and Matthew Perez came upstairs to Davis room where Malik Davis, Devan Dufour, and Matthew Perez discussed what to do with Jacquelyn Landry's body. It was decided amongst all three of them that Davis would be in charge of removing the body. At this time Davis requested that Dufour produce the needle used to inject Jacquelyn Landry Davis then flushed the needle, and remaining heroin down the toilet. During this time Davis discovered that the keys to Brandon Giangrosso's vehicle were missing. He and the occupants of the Laguna drive residence were never able to find the keys and the vehicle remained parked at 104 Laguna Drive. Davis, Dufour, and Perez then consumed more methamphetamine. Davis later removed the shower curtain from the upstairs bathroom and with Matthew Perez's help wrapped Jacquelyn Landry's body in the shower curtain. Davis later traveled to the target located on Ambassador Caffery Parkway and stole a green sleeping bag. Davis moved Jacquelyn Landry to the floor in his room and put her body into the sleeping bag. Davis called Monkurvis Irvin and requested that he help him move Jacquelyn Landry's body Irvin refused to help Davis. Davis later called Damone Campbell who traveled from Abbeville Louisiana. Campbell arrived at the house with a woman identified as Jada. Davis and Campbell went upstairs and Davis showed Campbell the body. Campbell stated that he could not help move the body because he was not in a truck and left the residence. Campbell never returned to help Davis. At some time between May 23 and May 26, 2017 Davis met up with Yancy Sonnier who sold more methamphetamine to him. Davis told Sonnier that a girl had overdosed and died at the residence. In the early morning hours of May 26, 2017 Perez moved all the occupants of the Laguna residence into the downstairs room occupied by Charles Franciol. At this time Davis moved Jacquelyn Landry's body downstairs and outside. He removed the trash located in the blue residential receptacle belonging to 104 Laguna Drive to the neighbors receptacle. Davis then deposited Jacquelyn Landry's body into the blue residential receptacle. Davis confirmed that the trash was removed during the morning hours of May 26, 2017. The Lafayette Parish Sheriff's office along with the operator of the landfill which received the residence garbage from the receptacle on Laguna Drive through the use of cadaver dogs searched the landfill but Jacquelyn Landry's Body was not found.
